



# Mandatory RRP Rule Certification Training

**DID YOU KNOW** that the EPA's new Renovation, Repair, & Painting (RRP) Rule requires most contractors and their companies to become RRP Certified?

The Environmental Protection Agency (EPA) has issued a final rule that addresses lead based paint hazards created by renovation, repair, and painting activities. The rule requires that renovation contractors, maintenance workers, painters\*, and other specialty tradesmen who disturb painted surfaces during their work to become RRP certified.

**This law went into effect on April 22, 2010.**  
**Renovators are now required**  
**to apply for certification from the EPA.**
